Bills in the General Account in the amount of \$ 24,335.74 and bills in the Highway Account in the amount of \$ 23,455.83 for a total of \$ 47,791.57 were audited and approved for payment with a motion made by Patty Bikowsky, 2<sup>nd</sup> by Brad Dixon, all in favor, so moved.
